Subject: - Regarding Supply of Cement to Contractor as per decision of the Govt., dated 07/08/2018.

Reference: - Your office letter No. HPSCSC/Pro/24 (36) RC- 2016-17-1-16931-16934 dated 26/09/2018 & No. 20788-791 dated 17/11/2018.

In reference to your office letters detailed above vide which service charges of Rs. 100/- PMT were demanded on the analogy of MGNREGA for supply of control rate cement from various godowns of HPSCSC situated in the state directly to the contractors of HPPWD against the permit issued by the concerned Executive Engineers. A meeting was also held in this regard in the office chamber of undersigned with officers of your corporation on dated 09/10/2018 to finalize the matter. The proposal received from your corporation vide letter dated 17/11/2018 was referred to the Govt., vide this office letter No. 21577 dated 20/11/2018 & No. 21784 dated 28/11/2018 to accord necessary approval regarding the Service Charges on cement as per your demand, which has been accepted by the Govt., and approval accorded by the Additional Chief Secretary (PW) to the Govt., of H.P. vide her office letter No. PBW (B) C (17)4/2018 dated 06/12/2018, copy of which is also endorsed to your office & others.


