

Subject:- Regarding debarring from tendering process from National Highway in the State of H.P.


As per the approval conveyed vide this office letter no 3776-78 dated 18.09.2019 in the public interest, the firm M/s R.K. Associate has been debarred from participation in the tendering process of National Highway works in Himachal Pradesh in future by the Executive Engineer NH Division HPPWD., Hamirpur vide his office letter no. PW/NHD/MHR/GA/Tender/2019-20 12495-12513 dated 02.01.2020. (Copy enclosed), as the services provided by the firm M/s R.K. Associate, H. No.388, Street No.6, Bharat Nagar, Patiala were not found satisfactory. He did not perform properly as per the job assigned i.e. preparation of Detailed Project Report and detailed design of Jangoli Khad Bridge. This caused huge variation in the quantities at site while execution of Jangoli Khad Bridge was taken up.

On the recommendation of undersigned and Superintending Engineer, National Highway Circle, Shahpur, the matter of debaring of your firm has been examined in the office of Worthy Chief Engineer, National Highway Shimla and it has been found that the services provided by your firm was not found satisfactory. Hence caused huge variation in quantities while constructing the bridge at site. Your firm was asked regarding this matter, but no satisfactory reply was given. The Ministry of Road Transport and Highways has also taken a very serious view for this kind of lapse on the part of your firm for not performing properly as per the job assigned to you i.e. Preparation of detailed project report and detailed design of Jangoli Khad bridge Km. 72/244 and asked to initiate action against the firm for debaring.
