



Sir,

I am directed to refer the subject noted above and to say that a meeting was held on 24-04-2013 under the chairmanship of Pr. Secretary (PWD) to the Government of Himachal Pradesh to review the progress of e-Procurement under item No. 11 of said meeting, it was decided after detailed discussion that e-tendering may be lowered to Rs. 10 Lakhs from the existing Rs. 40 Lakhs. In the first phase it is to be reduced to Rs. 20 Lakhs.

In view of the above, partial modification is made in Sl. No. 1 of this letter No. PWD(B)F(5)4/2010-II, dated 31-10-2011 and henceforth no tender of value of Rs. 20 Lakhs or more for works shall be floated except through e-tendering mode.
