Assignment Title: Consultancy Services for detailed feasibility of about 2000 Kms. and detailed engineering design including social, environmental and road safety safeguards for upgradation works of 650 Km. road length and maintenance works of 1350 Km. road length of Core Road Network of Himachal Pradesh for the proposed H.P. State Roads Project – II in the State of Himachal Pradesh.

The Government of Himachal Pradesh has applied for financing from the World Bank toward the cost of the Himachal Pradesh State Roads Project-Phase-II, and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include:-

- (i) Feasibility study of roads about 2000 Kms. length of core roads (including State Highways, Major District Roads & other state roads).
- (ii) Preliminary design, environmental & social assessment, final detailed design, including bioengineering solutions and bid documents for upgradation works of about 650 Kms. of roads.
- (iii) Preliminary design, environmental & social assessment, final detailed design and bid documents for maintenance works of about 1350 Kms. of roads.
- (iv) These services are expected to be delivered over a period of 18 months.

The Himachal Pradesh Road and Other Infrastructure Development Corporation Limited (HPRIDC) now invites eligible consulting firms (“Consultants”), to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are given in the Expression of Interest (EoI). The EoI includes the following documents:-

- (i) Section I- Instructions for submission of Expression of Interest and Guidelines for preparation of EoI..
- (ii) Section-II Eligibility and short listing Criteria including Annexure-I to V.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers” July 2016 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the QCBS method set out in the Procurement Regulations.

Section-I

Instructions for submission of Expression of Interest:

1.	Consultant shall go through the guidelines given below and section II before preparing EoI proposal.
2.	Consultant who meets short listing criteria given in section II, shall prepare EoI as per the guidelines. If the Consultant feels to submit certain information not covered in the guidelines would be in his interest, he may submit such information
3.	Accomplished Expression of Interest (Application) must be submitted together with a Letter of Intent not later than 15:00 hours (IST) on March 26, 2018 . Documents in support of all qualification information shall be submitted with application. Proposal of EoI with qualification information shall be furnished on/before the due date of submission at the address shown under para 12 here below.
4.	The Application shall be basis of drawing up a shortlist of eligible consultants who will be invited to submit proposal for services required.
5.	All Applications shall be submitted in English.
6.	Power of attorney (on stamp paper duly notarized) of the person submitting the Expression of Interest on behalf of the Applicant shall be attached. Joint Venture (JV) shall not have more than 3 members. One of the members should be a Lead Member.
7.	The Consultant (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture member in another Proposal, if a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected.
8.	The Application and all related correspondence and documents should be written in the English language. Supporting documents and printed literature furnished by Applicant with the Application may be in any other language provided that they are accompanied with translations in the English language. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Application, the English language translation shall prevail.
9.	HPRIDC reserves the right to reject any Applications, without assigning any reasons thereof.
10.	The Applicant shall provide all the information sought under this REOI Document. HPRIDC would evaluate only those Applications that are received in the required format and complete in all respects. Incomplete and / or conditional Applications shall be liable to rejection.
11.	No claims whatsoever will be entertained if submission is not received by due date and time.

14.	The Consultant shall submit a signed and complete EoI comprising the documents and forms in accordance with EoI documents.
15.	An authorized representative of the Consultant shall sign the original submission letters in the required format for EoI submission and shall initial all pages. The authorization shall be in the form of a written power of attorney attached to the EoI Proposal.
16.	The signed EoI shall be marked " ORIGINAL ", and its two copies marked " COPY-1 & COPY-2 " as appropriate. Copies shall be made from the signed original. If there are discrepancies between the original and the copies, the original shall prevail.
17. Guidelines for Preparation of Expression of Interest

	Following information shall be submitted using given formats and where no formats are specified, free format can be used.
1.	Complete name of firm, date of establishment and type of organization whether individual, proprietorship, partnership, private limited company, public limited company etc. (Annexure I).
2.	Exact and complete corporate/registered/home office address, business address, telephone numbers, fax numbers, E-mail and cable address. For consultant of foreign registry, indicate if there is any branch office(s) established in India with details in aforesaid manner. Information is to be furnished by sole applicant or members of JV individually (Annexure I).
3.	If present firm is the successor to or outgrowth of one or more predecessor firms, fresh name(s) of former entity (ties) and year(s) of their original establishment with details in aforesaid manner. Information is to be furnished by sole applicant or members of JV individually (Annexure I).
4.	Present a brief narrative description of the firms. Information is to be furnished by sole applicant or members of JV individually (Annexure I).
5.	List of not more than two (2) principals who may be contacted by this Office. Listed principals must be empowered to speak for him or for the firm on policy and contractual matters. Information is to be furnished by sole applicant or members of JV individually. (Annexure I)
6.	Under this item, indicate financial figures from consultancy business for past 5 (five) financial years. (Annexure II)
7.	Organizational strength of consultant and its constituents in case of a JV shall be given. (Annexure III)
8.	Consultant's experience shall be given under three categories. The first category (A) would be Detailed Design, DPR & bid documents preparation (on item rate) experience for roads (B) Rehabilitation/ Strengthening of existing bridges – Design & DPR preparation (on item rate) experience (C) Detailed design of Intermediate/ 2-lane roads & bridges in hilly terrain. Experience in above three categories would be reported for similar nature road works and other widening, improvement and strengthening and / or rehabilitation of road works & bridges. In case of JV applicant, each member has to likewise give above information. Only those works which are done as prime consultant need to be reported. (Annexure IV)
9.	As many references from employers as the consultant (for each member in case of JV) may choose shall be submitted.
10.	An undertaking for supply of true information shall be given as per Annexure V .

Section - II

Short Listing Criteria

A. Annual Turn Over

- (i) Annual turnover of any one of the last five financial years i.e. from 2012 -2013 to 2013-2017 updated to the current financial year shall be more than Rs. 20 crores. In case of JV, the lead member shall have more than Rs. 14 crores of annual turnover (updated) of any one of the last five financial years. This threshold for each other member of JV shall be more than Rs. 8 crores.
- (ii) For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement/updating factor corresponding to that year given in the **Annexure-II**.

B. Experience

1. Consultant must have as prime consultant successful experience as follows:
 - (i) (a).The Experience of Detailed Design and DPR Preparation (on item rate) of the road project shall be in respect of projects involving not less than 350 km of road work in each project. For JV, qualifying length for lead member would be 250 km of road work (for each project) and for other partner's it would be 150 km of road work (for each project). Such Projects must have been completed within last five Calendar years including 2017.
 - (b). The Experience as feasibility study shall be in respect of projects involving not less than 1000 km of road work in each project. For JV, qualifying length for lead member would be 700 km of road work (for each project) and for other partner's it would be 300 km of road work (for each project). Such Projects must have been completed within last five Calendar years including 2017.
 - (c) Experience in preparation of feasibility & DPR documents for addressing the Environment and Social issues within Environment and Social Management Framework for similar 2 no. road projects within last five Calendar years including 2017.
 - (d) Experience in externally aided projects shall be given preference.

C. ORGANISATIONAL STRUCTURE & PERMANENT STAFFING :

- (a) At least 7 years in the business of preparing DPRs with minimum 3 years in DPRs in Hill Road experience.
- (b) At least 3 no. of permanent Key-Saff.

A Project would qualify as similar Project if it meets with following:

- (a) Widening & Strengthening of existing roads (by not providing separate carriageway)

Consultant must satisfy A, B and C for becoming eligible for short-listing.
