In the event of his not joining the post within stipulated period i.e. within 15 days after the issue of order,, offer of promotion shall be deemed automatically withdrawn without notice and opportunity to next official in the line shall be given.

If the promotee proceeds on leave to avoid his joining in his new place of posting within stipulated period , disciplinary action will be initiated against the defaulter.

If an official forgoes his promotion then he will be considered for promotion after one year or whenever the post is available, whichever is later.

The above order are subject to any court case pending in the Hon.'ble Court/Tribunal


