Short title and Commencement	1.	(i)	These rules may be called the Himachal Pradesh Public Works Department, Assistant Engineer (Civil), Class-I (Gazetted) Recruitment and Promotion (7 <sup>th</sup> Amendment) Rules, 2020.
		(ii)	These rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.
