The Committee constituted for considering a request for appointment on compassionate grounds should limit its recommendation to appointment on compassionate grounds in really deserving case and only if vacancy meant for appointment on compassionate grounds is available within a year in the concerned department, within the ceiling of 30% of vacancies falling under Direct Recruitment (DR) quota, in Class-III & Class-IV posts.
