**Sub: - Uniform overhead charges to Himachal Pradesh for adoption in Schedule of Rates.**

Dear *M.S. Thakur*

Kindly refer NRRDA letter no. P-17023/ 5/ 2005-P-I dated 23.01.2006 vide which the State was permitted in preparation of Schedule of Rates based on SDB the provision of Contractor's profit and Overhead charges @ 19% (based on State practice of 10% CP, 5% OH, 1.5% water charges, 2.5% additional for PMGSY practice) on cost of labour and material only can be taken. In machinery the rental already include the CP & OH and such the remaining component of only 2.5% could be permitted on hired machinery and carriage.

For streamlining the procedure of Schedule of Rates preparation, the matter is considered in the SOR Scrutiny Committee constituted by Director General of NRRDA and it is decided that an overall 12.5% contractor's profit plus overhead charges (10% contractor's profit and 2.5% overhead charges) may be permitted to all the States for road works including protection and CD works and an overall 20% contractor's profit and overhead charges (10% contractor's profit and 10% overhead charges) may be allowed on bridge works having span more than 15m. In addition to this, 1% labour cess may also be allowed on all the items.

In light of above recommendation the State is requested to correct their SOR which is currently applicable and intimate to NRRDA accordingly.
