"OFFICE ORDER"

On the recommendations of the departmental promotion committee, **Shri Suresh Kumar Sharma, Kanungo** presently working in NH. Sub-Divn. HPPWD., Jukhala under NH. Division HPPWD., Hamirpur in the pay scale of Rs: 10300-34800+GP.4200, is hereby promoted to the post of Naib Tehsildar in the pay scale of Rs: 10300-34800+GP. 4800 on regular basis from the date of his actual joining the post:-

The above promotion to the post of Naib Tehsildar is subject to the final outcome of the O.A. No. 5826 of 2018, Suresh Sharma Vs State of HP & others pending in the Hon'ble HP. Administrative Tribunal Shimla-2.

Before the above order is implemented, the concerned Head of the office will ensure that the promotee fulfil the appended conditions:-


1. The above promotee will join at the place of his/her posting on promotion within 15 days from the date of issuance of this order failing which the promotion orders shall be deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.
2. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if some one applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting /appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
3. The above promotion is subject to review due to any consequential administrative reasons.
4. Those who have been posted outside the sub-cadre/Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
5. That in case of any factual error/omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved on promotion to the next station.
6. Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/ vigilance case is pending against the said official.
7. Their academic qualification & departmental examination certificates may also be verified before relieving.



8. The financial benefit will be admissible to the promotee from the date of joining and his pay will be fixed as per the provision of FR-22 (i)a(i) for which he can exercise his option for fixation within one month from the date of joining.

Consequent upon his promotion, the posting orders are hereby ordered as under with immediate effect in the public interest:-
