Public Service Commission and Himachal Pradesh Staff Selection Commission, Hamirpur, for recruitment to various posts to be filled up :

1. on compassionate grounds,
2. against 3% sportspersons quota,
3. from amongst the specially abled persons,
4. on batch-wise basis as per specific method provided in the respective recruitment rules, and
5. posts reserved for Ex-servicemen.

2. In all other cases, the respective Administrative Departments will take decision on the ongoing recruitment processes after examining all the aspects and after obtaining approval of Hon'ble Chief Minister, H.P at their level.


