NOTIFICATION

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor of Himachal Pradesh is pleased to frame the following Rules to determine the eligibility for appointment to Class III and Class IV posts within or outside the purview of the Himachal Pradesh Public Service Commission, Shimla, Himachal Pradesh Staff Selection Commission, Hamirpur, as under:

Short title	1.	These rules may be called "The Himachal Pradesh Eligibility for Appointment to Class III and Class-IV Posts, Rules, 2019."
Commencement and Effect.	2.	(1) These rules shall come into force with effect from the date of publication in the official Gazette (E-Gazette) H.P. (2) These rules may be read with Clause 7 of the Recruitment and Promotion Rules framed under article 309 of the Constitution of India in any Government Department for any Class III and Class IV posts. (3) These Rules shall also apply to other

Definitions	3.	<p>Government undertakings/Corporations/Board/Autonomous Bodies etc. subject to adoption thereof.</p> <p>In these Rules, unless the context otherwise requires:-</p> <p>(a) "Constitution" means the Constitution of India;</p> <p>(b) "Governor" means the Governor of Himachal Pradesh;</p> <p>(c) "Government" means the Government of Himachal Pradesh.</p> <p>(d) "Bonafide Himachali" means a person, who has been defined as such by the Government of Himachal Pradesh from time to time.</p>
Eligibility for recruitment.	4.	<p>A. candidate shall be eligible for appointment to Class III post(s), if he/she has passed Matriculation and 10+2 and for Class IV post(s), if he/she has passed Middle or Matriculation from any School/Institution situated within Himachal Pradesh;</p> <p>Provided this condition shall not apply to Bonafide Himachalis.</p>

हिमाचल प्रदेश की सभासल शाखा के संविधान के अनुच्छेद 309 के पर-तुक द्वारा फलत शक्तिपूर्वक प्रयोग करने हुए हिमाचल प्रदेश लोक सेवा आयोग, शिमला, हिमाचल प्रदेश वर्ग-गुरी गणन अधीन लखीरपुर की कार्यक्षेत्र के अन्तर्गत या के बाहर वर्ग III तथा वर्ग-IV के पदों पर नियुक्ति के लिए पात्रता निर्धारित करने लिए निम्नालिखित नियम बनाते हैं

संविधान नियमों	1	इन नियमों का संश्लेष नाम "हिमाचल प्रदेश वर्ग III व वर्ग IV के पदों पर कर्तव्य हेतु पात्रता नियम, 2019" है।
नियमों का प्रयोग	2	(1) ये नियम राजपत्र (इ-गजट), हिमाचल प्रदेश में प्रकाशित किए जाने की तारीख से प्रवृत्त होंगे। (2) इन नियमों को सरकार के किसी भी विभाग में भारत के संविधान के अनुच्छेद 309 के अन्तर्गत बनाए गए वर्ग III और वर्ग IV के पदों के गती और प्रोन्नति नियमों के खण्ड 7 के साथ प्रवृत्त जाए।
परिभाषाएँ	3	(3) ये नियम अन्य सरकारी उपक्रमों/निगमों/बोर्डों/स्वायत्त निकायों इत्यादि पर इनके अंगीकृत करने पर लागू होंगे। इन नियमों में जब तक कि संदर्भ से अन्यथा अपेक्षित न हो। (क) "संविधान" से भारत का संविधान अभिप्रेत है; (ख) "राज्यपाल" से हिमाचल प्रदेश का राज्यपाल अभिप्रेत है; (ग) "सरकार" से हिमाचल प्रदेश की सरकार अभिप्रेत है; (घ) "हिमाचल के स्थाई निवासी" से ऐसा व्यक्ति अभिप्रेत है जो समय-समय पर हिमाचल प्रदेश सरकार द्वारा इस प्रकार परिभाषित किया गया है।
