Sir/ Madam,

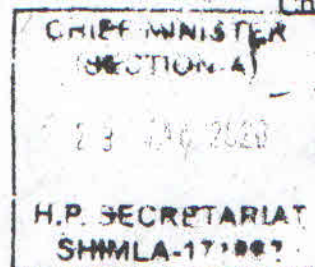
