Subject: Installation of sustainable waste processing equipment in canteens of Central/State Government departments under the recommendation of Apex Monitoring Committee-reg.

The undersigned is directed to intimate the Apex Monitoring Committee (AMC) constituted under order of National Green Tribunal (NGT) and chaired by Hon'ble Justice D.K.Jain, former Judge of the Supreme Court of India had, during their 4<sup>th</sup> meeting held at New Delhi on 19<sup>th</sup> December 2018, desired that all Central/State Government departments with canteens shall install sustainable waste processing equipment onsite.

2. In this regard, departments may refer to suitable mechanical models available on the GeM platform or alternative pit based waste processing system. Various advisories on the subject are available on the Swach Bharat (urban) portal under the Knowledge Management dropdown Manuals/Technical Advisories.
