Strengthening of Administrative-Review of cases of Govt. servants attaining the age of 50/55 years or completing 30 years of service under the H.P. Civil Services (Premature Retirement) Rules, 1976. Guidelines relating to action where integrity of the Government servant is doubtful.

Sir/Madam,

I am directed to invite your attention to this Departments letter of even number dated 16/18-11-1985 vide which instructions were issued to assess the suitability of Government servants for further retention in service beyond the age of 50/55 years or completion of 30 years of service and to weed out those whose integrity is doubtful.

The Hon'ble High Court of Himachal Pradesh in CWPIL No. 211 of 2017 has issued directions to the Government to evolve a Policy mechanism to ensure that where integrity of the officer/official is under doubt, he should not be given sensitive or administrative posting and also to explore the possibility of invoking its power to retire the Government employees/officers/officials pre-maturity in public interest wherever they have become deadwood or liability on account of their doubtful integrity.

Hence, the aforesaid instructions are re-iterated and be adhered to strictly by all concerned in order to ensure compliance of Hon'ble Court orders.
