NOTIFICATION

In continuation to this department notification No. PBW(B)B(1)/2018 dated 16/2/2019, the Governor, Himachal Pradesh on the recommendation of the Selection Committee, is pleased to appoint Shri Yashpal Singh Verma, HPAS (Retd.) as OSD in Special Land Acquisition Unit, Paonta Sahib, Distt. Sirmour, HP for look after all aspects of land acquisition for National Highways/NHAI Projects including other central Government Projects from the date of his joining.

2. The payment of salary, other allowances and other expenses on this account would be made from Administrative Charges admissible @2.5% of NHAI funds available for meeting out such costs. The terms and conditions of his appointment shall be as under:-

(i) Salary: His pay shall be fixed on the basis of last pay drawn minus pension and shall be regulated in accordance with the provisions contained in the HP State Civil Services (Fixation of Pay of Re-employed persons) orders, 1988 circulated by the Finance Department vide O.M NO. Fin (C)-B(7)-10/84 dated 1-12-1988 read with O.M No. Fin (C)-B(7)-13/2009 dated 19-4-2010 as amended from time to time.

(ii) Tenure: The tenure of appointment shall be for a period of one year, provided that the Government can terminate this appointment even before the expiry of the above period by serving notice of one month in advance or by paying one month's salary in lieu of notice of one month in case the conduct and performance of the incumbent is not found satisfactory or if the Government decide to fill up the post, in question, by regular appointment as the case may be.

(iii) Leave: The provisions of CCS (Leave) Rules, 1972, shall not be applicable to the re-employed pensioner and he will also not be entitled to LTC/HTLTC facility. However, he will be entitled to one casual leave for each completed months.

- (iv) TA/DA: He shall be entitled to TA/DA as per admissibility to Class-I officers of the State Government under the concerned Rules.
- (v) Residential Accommodation: He shall be entitled to the allotment of Government Residential Accommodation, if available or otherwise he will be entitled to receive House Rent Allowance as per State Government Rules and instructions in this regard.
- (vi) Medical Facility: He shall be entitled to avail medical facilities and grant of re-imbursment of Medical Expenses as admissible to Class -I officer of the State Government.
- (vii) Gratuity and Death-cum-retirement: He shall not be eligible for gratuity and Death-cum-retirement and Death-cum-gratuity for the period of said re-Retirement.

- (viii) Other facilities: He shall be entitled to the other facilities as admissible to the State Government Employees.
