



Policy to regulate the services of Part- Time Workers.

Sir,

I am directed to invite your attention to this Department's letter of even number dated 4th May, 2017 regarding policy to regulate the services of Part-time Workers and to say that it has now been decided that Part-Time Workers including Part-time Water Carrier(s) of Education Department completing eight (8) years of continuous service as on 31<sup>st</sup> March, 2018 and 30<sup>th</sup> September, 2018 respectively in all Government Departments will be converted to Daily Wager subject to the observance of following terms and conditions:-

Part-Time Class-IV Workers after completing eight (8) years of continuous service as on 31<sup>st</sup> March, 2018 and 30<sup>th</sup> September, 2018 will only be made Daily Wagers. Posts so vacated by such Part Time Workers shall stand abolished.

The orders to this effect will be issued at the level of Head of Department after verifying the facts.

For determination of Date of Birth of the candidate concerned, the provisions as laid down in Rule 172 of HP Financial Rules, 2009 and instructions issued under Rule-7.1 of HP Financial Rules, 1971 Vol.I shall be observed.

The conversion to daily wager status shall only be from prospective effect i.e. after the date of issuance of these orders after completion of all codal formalities.



5. The autonomous Boards and Corporations including the Universities are not required to follow these orders mutatis-mutandis but should decide the same depending on their own financial position.
6. Such Part-Time workers, who have been engaged without being sponsored by the Employment Exchange may be given relaxation while conversion.
7. After conversion the Part-Time Workers as daily wager, the information should come to the Finance Department for effective monitoring.

2. This issues with the prior concurrence of the Finance Department obtained vide their U.O. No. 53506143-Fin-F/2018, dated 5<sup>th</sup> November, 2018.

3. These instructions may be brought to the notice of all concerned for strict compliance and receipt of the same may also be acknowledged.


