(Monthaly return for the works awarded .

As all you are well aware that the subject cited review petition is pending before the Hon'ble High Court of H.P., and now listed for 04/01/2018 to file compliance affidavit by additional Chief Secretary (PW) to the Govt., of H.P., In compliance to the directions of the Hon,ble court of H.P. dated 16/11/2017 detailed compliance affidavit was filled by Public Works Department showing the detail of works in which class A contractor has been awarded the tender below Rs. 80.00 lac and class B contractor have been awarded the tender below Rs. 30.00 lac after 27-05-2015 with the reason under what circumstances these works have been awarded to ineligibles class of contractors which is against the enlistment rules 2015 that too on the basis of information received from all the Divisional offices of HP PWD.

This case was listed on 21/12/2017 and the Hon'ble court is not satisfied with information so provided by the department and had taken serious view for violation of enlistment rules 2015 that too after its decision dated 01/04/2016 and as such passed directions/order as to how the department intend to curb these violations of enlistment rules 2015, in future.

Hence the whole matter has been examined in this office and it has been decided that henceforth all the Chief Engineers will strictly ensure for implementation of the enlistment rules 2015 by all the Executive Engineers in HPPWD, in spirit and letter. Any deviation from these rules will be treated as violation of rules thus action under CCS /CCA Rules 1965 shall be imitated against the defaulter officer. Hence henceforth it is also decided that all the Executive Engineer shall provide the information of all the works awarded to the contractors as per their eligibility of class at the end of every month on the Performa enclosed as annexure "A" with necessary certificate that all the works have been awarded to the eligible class at the end of the of contractors as per enlistment rules 2015 duly countersigned by the their Superintending Engineer to their zonal Chief Engineers every month up to the 10th day of the preceding month positively
