

NATIONAL COMPETITIVE BIDDING

1. The Government of India has received a loan from the International Bank for Reconstruction & Development towards the cost of Himachal Pradesh State Roads Project and intends a part of the funds to cover eligible payments under the contracts for construction of works as detailed below. Bidding is open to all Bidders from eligible source countries as defined in the "Guidelines: Procurement under IBRD Loans and Credits". Bidders should be Special Class or equivalent Contractors, registered with the Government of Himachal Pradesh, or other State Government/ Government of India, or State/Central Government undertakings. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Bidders and Section III Evaluation and Qualification Criteria to qualify for the award of the contract.
2. Chief Engineer (Kangra Zone), HP PWD, Dharamshala on behalf of Governor of Himachal Pradesh invites bids for the construction of works detailed below:-
Project Scope & Duration: To undertake Ordinary Maintenance, Initial Rectification Works, Periodic Maintenance Work and Minor Improvement Works and Emergency Works on selected road approximately 126.093 Kilometres in Kangra District. The contract duration is for a period of 5 years. The maintenance work will also include improvement of riding quality of carriageway, cross drainage/retaining wall/breast wall works, minor work on culverts/ bridges and roadside maintenance within the select road limits. The Ordinary Maintenance works will be carried out under performance based road maintenance on a lump sum basis paid monthly throughout the five years. Initial Rectification (to be carried out in the first 9 months) and Periodic Maintenance (to be carried out in selected sections of the road in each of the first 4 years) will be paid on measured quantity to the value of the Lump Sum and Minor Improvement Works (to be carried out during the course of the first year of the contract) will be paid on the basis of actual quantities of work completed. There is a requirement for specialized maintenance road construction equipment.
3. Bid documents may be purchased from the Chief Engineer (Kangra Zone) HP:PWD, Dharamshala from 22nd December, 2014 to 20th January, 2015 during office hours i.e., from 10:30 AM to 05:00 PM. (IST), for a non-refundable fee of Rs.10,000/- The mode of payment shall be in the form of DD drawn in favour of Executive Engineer, HPPWD, Division Palampur on any scheduled Bank payable at Kangra. Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs 500/- The Chief Engineer Kangra Zone HP:PWD Dharamshala will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same. Bidders are strongly encouraged to purchase the bidding documents prior to the pre-bid meeting (refer Item 9 below) in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
4. Bids shall be valid for 90 days after the dead line date specified for submission.

5. Bids must be accompanied by bid security of the amount specified for the work in the table below in the form of Demand Draft or Bank Guarantee. If Demand Draft form is adopted, it should be payable at Kangra and drawn in favour of Executive Engineer, HP:PWD, Division Palampur. If Bank Guarantee form is adopted it should be drawn in the favour of The Executive Engineer, HPPWD Division, Kangra. Bid security will have to be in any one of the forms as specified in the Bidding document and shall have to be valid for 45 days beyond the validity of the Bid.

Bids must be delivered to the Office of Chief Engineer (Kangra Zone) HPPWD Dharamshala on or before 1100 hours (IST) on 22nd January, 2015 and will be opened on the same day by Chief Engineer Kangra Zone at 1130 hours (IST) in the presence of Bidders or their representatives who choose to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.

9. Bidders are invited to attend a workshop and Pre Bid Meeting on dated 2nd January, 2015 at 1100 hours, in the office of Chief-Engineer (Kangra Zone) HPPWD, Dharamshala to clarify issues and to answer the questions on any matter that may be raised at that stage as stated in Clause 7.4 of 'Instructions to Bidders' of the bidding document
